ORDER:

In the Government order first read above, the Government accorded administrative sanction for implementation of Chief Minister's Green Fellowship Programme (CMGFP) through a knowledge partner by utilizing the available funds under Environmental Management Agency of Tamil Nadu (EMAT) of Department of Environment and Climate Change (DoE&CC) at a total cost of 6.00 crores.

2. In the Government order 2nd read above, sanction was accorded for the implementation of the Chief Minister's Green Fellowship Programme with the Institute of Energy Studies (IES), Anna University under clause (bb) Section 16 of the Tamil Nadu Transparency in Tenders Act, 1998 within the

sanctioned outlay of Rs.5,99,08,400/- (Rupees Five Crores Ninety Nine lakhs Eight Thousand and Four Hundred only) as per Government order first read above.

3. In the Government order 4th read above, orders were issued sanctioning an amount of Rs. 35.68 Crore, for carrying out 11 activities under the Tamil Nadu Climate Change Mission for the year 2024-25. Among others, an amount of Rs.4.85 Crore has been sanctioned for Chief Minister's Green Fellowship Programme for the period April 2024 to March 2025.

4. In the letter 5th read above, the Director of Environment and Climate Change has stated that in the Government letter third read above, the Government had accorded permission to extend the duration of implementation of the Chief Minister's Green Fellowship Programme upto 31.7.2025. Hence, he has requested the Government to sanction the remaining amount of Rs.1,51,72,500/- (Rupees One Crore Fifty-One Lakhs Seventy-Two Thousand Five Hundred only) which is required for implementation of CMGFP during the period from April 2025 - July 2025 (Four Months).

5. After careful examination of the proposal of the Director, Department of Environment and Climate Change, the Government hereby accord sanction for a sum of Rs.1,51,72,500/- (Rupees One Crore Fifty-One Lakhs Seventy-Two Thousand Five Hundred only) for implementation of CMGFP during the period from April 2025 - July 2025 within the provisions of the Budget Estimate, 2025-2026.

6. The amount sanctioned in para-5 above shall be debited under the following head of account:
