ORDER:-

In the Government Order first read above, Government have accorded administrative sanction for implementation of the ‘Chief Minister’s Green Fellowship Programme’ as detailed therein in 38 districts of Tamil Nadu for two years at a total cost of Rs.6.00 crore from the available funds of Environment Management Agency of Tamil Nadu (EMAT) of the Department of Environment.

In the said Government Order, the Government have also directed that the Director of Environment shall take necessary action for selection of the Knowledge Partner to implement the scheme.

2. In the Government Order second read above, a committee was constituted to select a knowledge partner under clause (bb) of Section 16 of Tamil Nadu Transparency in Tenders Act 1998 with the following members:-

Indian Institute of Technology, (Madras)

Joint Chief Environmental Engineer (Retired).

3. The above said Committee examined the proposal in detail and also looked at a presentation made before that. The committee after detailed deliberations came to the conclusion that the Institute of Energy Studies (IES), Anna University is capable of implementing the project as the knowledge partner. The committee therefore recommended to select the Institute of Energy Studies, Anna University, to be the knowledge partner for implementation of the Chief Minister's Green Fellowship Programme by exempting them from the Tender Transparency Act under clause (bb) of Section 16 of Tamil Nadu Transparency in Tenders Act, 1998.

4. The Government, after careful examination, have decided to accept the recommendations of the aforesaid Committee and accord approval for implementation of the "Chief Minister's Green Fellowship Programme" with the Institute of Energy Studies (IES), Anna University, under clause (bb) of Section 16 of Tamil Nadu Transparency in Tenders Act, 1998.

5. Necessary notification under Clause (bb) of Section 16 of Tamil Nadu Transparency in Tenders Act, 1998 will be issued separately by the Finance (Salaries) Department.

6. This order issues with the concurrence of Finance Department vide its U.O.No.46629/Finance/2022.dated.2/11/2022.
