ORDER :

In the Government Order first read above, orders were issued to constitute the "Tamil Nadu State Wetlands Authority" under the Chairmanship of Chief Secretary to Government along with the Members. The Additional Principal Chief Conservator of Forests is working as a Member Secretary of "Tamil Nadu State Wetlands Authority".

2. During the Budget Speech for the year 2021-22, the Hon'ble Minister for Finance and Human Resources Management has made the following Announcement among others :

"Under the leadership of Hon'ble Chief Minister, this Government will launch the 'Tamil Nadu Wetlands Mission' with the objective of ecological restoration of wetlands in Tamil Nadu. The Mission will identify and map 100 wetlands in 5 years from 2021-2022 to 2025 2026 and restore the ecological balance with focus on livelihood options at a cost of Rs.150 crores."

3. In the Government Order second read above, orders have been issued to implement the Tamil Nadu Wetlands Mission for a period of five years from 2021-2022 to 2025 2026 at an amount of Rs.115.15 crores.

4. The Government have decided to appoint the Additional Principal Chief Conservator of Forests and Member Secretary, Tamil Nadu State Wetlands Authority as the Mission Director for Tamil Nadu Wetlands Mission (Ex-Officio) to implement the Mission activities effectively.
