ORDER:

In the Government Order first read above, the Government have enhanced the financial powers to Secretaries to Government to enable disposal of cases expeditiously without reference to Finance Department.

2. Nature camp is an outdoor educational program that connects children or young adults with nature through immersive, hands-on experiences. These camps typically take place in natural settings such as forests, lakes or hill areas and emphasize outdoor activities like trekking, wildlife observation, environmental education and much more. The goal is to foster a deeper understanding and appreciation of the natural world, promote physical activity and teach valuable life skills. The "Nature experience" for children and teachers has vast potential to trigger their sensitivity towards nature appreciation and conservation, leading to positive environmental actions at different levels. It also aims to create greater awareness, understanding and empathy of children with and for the environment. In the letter second read above, the Principal Chief Conservator of Forests & Chief Wildlife Warden has sent a proposal to conduct Nature camps for Government School Students at Sathyamangalam Tiger Reserve. The detailed cost estimate for conducting nature camp for Government School Students at Sathyamangalam Tiger Reserve are as follows:-

3. The Principal Chief Conservator of Forests and Chief Wildlife Warden has requested the Government to sanction a sum of Rs.6.00 lakh under the discretionary funds of Principal Secretary to Government for "Nature camps for Government School Students at Sathyamangalam Tiger Reserve".

Based on the orders issued in Government Order first read above, the Government after careful examination, sanction an amount of Rs.6,00,000/- (Rupees six lakh only) for "Conducting Nature Camps for Government School Students at Sathyamangalam Tiger Reserve" for the year 2024-2025 by utilizing the Discretionary fund of Secretary.
