ORDER:

In the notification first read above, by virtue of the Wetland (Conservation and Management) Rules, 2017 the Government of India have constituted, State Wetland Authority in each State with the members specified therein as follows:-

2. In the Government Order second read above, the Government have notified the reconstituted "Tamil Nadu State Wetland Authority" under the Chairpersonship of the Hon'ble Minister (Forests).

The Principal Chief Conservator of Forests and Member Secretary, Tamil Nadu State Wetland Authority has now furnished a proposal in the letter third cited for reconstitution of Tamil Nadu State Wetland Authority as the three years tenure of five non official members (Expert Members) had expired.
